Summary: On July 31, 2018, the Board of Supervisors will consider instructing the Director of Public Health, in consultation with County Counsel, to report back to the Board in 30 days with recommendations for including e-cigarettes and marijuana in the existing County smoke-free ordinances and strengthening and broadening the existing ordinances to reflect best practices and promising policy innovations.
